Admissions & Continued Occupancy Policy for the Public Housing Program Summary of Changes

Throughout the 18 Chapters governing the Admissions & Continued Occupancy Policy the following changes have been made:

- ➤ General grammar, typo corrections and document formatting changes have been made throughout the policy.
- Language has been added and or removed to clarify the existing policies as recommended by NMA.
- ➤ Modification to the Local Preferences:
 - o Modify the working preference to remove "30 hours or more a week" and no longer stipulate the amount of hours, only that they are verifiably employed.
 - o Remove the Involuntary Displacement Preference
- ➤ Regulatory updates have been added or modified to be current with HUD regulations and PIH Notices. The bulk of revisions come in the form of changes brought about by the Streamlining Administration Regulations Final Rule, issued March 8, 2016, in addition to Notice PIH 2016-05 and PIH 2016-06, which set forth implementation guidance for the final rule.
- ➤ Updates supporting the *Federal Register* notice regarding the Violence Against Women Reauthorization Act of 2013 (VAWA).
- ➤ Policy changes concerning flat rent requirements mandated under the 2014 appropriations act and outlined in Notice PIH 2014-12 and its accompanying PIH-Issued FAQs.
- ➤ Updated policies regarding service animals, assistance animals, and pets, incorporating the latest guidance including Notice FHEO 2013-1
- ➤ A revised clarifications regarding the definition of *extremely low-income (ELI)* family, area median income and other requirements as per the *Federal Register* notice published June 25, 2014
- ➤ Updates to the list of federally mandated income exclusions as published in the *Federal Register*
- > Updates to policies on the use of arrest records per Notice PIH 2015-19
- ➤ Clarification on the Community Service Requirement
- > Clarifications regarding the definition of tuition, as specified in Notice PIH 2015-21
